- a) Approve appointment of Kristine Schmidt as the County of Santa Barbara Human Resources Director beginning January 2, 2024; and
- b) Determine that the recommended actions are not a project under the California Environmental Quality Act (CEQA) pursuant to CEQA Guidelines Section 15378(b)(2) because the recommended actions involve continuing administrative or maintenance activity.

Summary Text: This item is on the agenda to approve the appointment of Kristine Schmidt to the position of Director of Human Resources. Ms. Schmidt was selected by the County Executive Officer following a national search to replace Maria Elena De Guevara, who is retiring from the position in January 2024. Ms. Schmidt has extensive experience in human resources management for local government jurisdictions, including chief labor negotiator, employee benefits, employment policy development and implementation, civil service recruitments, pension plan amendments and fiscal analysis related to labor negotiations.

Ms. Schmidt will begin her tenure with the County of Santa Barbara on January 2, 2024.

Background:

Ms. Schmidt is currently the Assistant City Manager for the City of Goleta and has served in that position since 2019. Prior to this position, she worked for the City of Santa Barbara from 2002 through 2019 in various human resources, employee relations and administrative services positions. She began her career in the human resources field in 1991. She holds a Juris Doctorate from the Santa Barbara College of Law.
