Title: Release fund balances for Taser 10

Budget Action: Increase appropriations of \$547,900 in Sheriff General Fund for Capital Assets - Equipment funded by release of Restricted Sheriff Asset Forfeiture-State fund

balance (\$300,000), release of Committed Sheriff Projects fund balance (\$198,900), and an Intrafund Expenditure Transfer(-) in from General County Programs. Increase appropriations of \$49,000 in General County Programs General Fund for Intrafund Expenditure Transfers(+) funded by release of

Restricted Public Safety Prop 172 fund balance.

Justification: The Sheriff's Office equips all law enforcement deputies and custody facilities with Axon tasers as less lethal equipment to safely deescalate violent

encounters while minimizing use of force. The department's current tasers are reaching the end of their useful life and will be replaced with the Taser 10 plan, for which current year costs of \$851,200 will be funded with multiple sources. This budget revision releases from fund balance Sheriff's Office Asset Forfeiture funds (\$300,000) and Sheriff's Office Special Projects funds (\$198,900) set aside in prior years for the taser purchase, and transfers from Proposition 172 fund balance in General County Programs (\$49,000) that was previously approved, but unused, in FY 22/23, with the remainder (\$303,300) to be paid through existing Sheriff's Office FY 23/24 appropriations currently budgeted for this purpose. Future year costs of \$302,975 per year will be paid from existing ongoing
