Dear Santa Barbara County Supervisors,

I would like to comment on the prospective Rooster Ordinance. I have kept several roosters over the years that I have lived in Cebada Canyon, but only one at a time since they will fight to become that 1 rooster to that flock of hens. It is hard to understand how certain of our neighbors have been allowed to house many roosters on their properties in small cages next to each other, The resulting continuous crowing has driven longtime residents from their homes, lowering the property value since no one wants to live with more than 1 rooster next door, except for those who can find a way to make money feeding into the illegal blood-sport of cockfighting. Why should raising 20 roosters be allowed in our EDRN when their only use is illegal activity. I suppose someone could be raising heirloom breeds of chickens for preservation of genetic diversity and living agricultural history. That farmer would have a full complement of hens to make the venture possible. Of course someone might raise young male chickens for meat, but I would think that person would harvest them prior to, or shortly after, sexual maturity (and crowing behavior). Yes, cockfighting is allowed in Mexico, but I'm pretty sure they are not being exported.
