CIRCUMSTANCES:

County employees have invaded Mr. Crable's privacy, placed Mr. Crable in a false light, and have caused significant emotional distress by disclosing Mr. Crable's private health information to his coworkers. Both the disclosures and the impact to Mr. Crable's reputation and work environment have been continually causing harm since approximately October 19, 2022. On or around March 15, 2023, Mr. Crable learned that a colleague attempted to enter his property to perform an evaluation for an involuntary psychiatric hold based on the disclosures made by county employees. Mr. Crable has reported this matter to his employer, the County of Santa Barbara, as required by Gov't Code sections 910.8 and 911, by means of the attached letter, and submits this Claim out of an abundance of caution. The County has already initiated an investigation.
