#### FIRST AMENDED AGREEMENT FOR SERVICES OF INDEPENDENT CONTRACTOR

THIS FIRST AMENDMENT to the Agreement for Services of Independent Contractor, referenced as <u>BC 23-076</u>, (hereafter First Amended Agreement) is made by and between the County of Santa Barbara (County or Department) and **Davis Guest Home, Inc.** (Contractor) for the continued provision of services specified herein.

WHEREAS, Contractor represents that it is specially trained, skilled, experienced, and competent to perform the special services required by County, and County desires to continue to retain the services of Contractor pursuant to the terms, covenants, and conditions herein set forth;

WHEREAS, on July 18, 2023, the County Board of Supervisors authorized the County to enter into an Agreement for Services of Independent Contractor, referred to as BC 23-076, for the provision of intensive residential treatment services for a total maximum contract amount not to exceed \$565,000, inclusive of \$215,000 for FY 22-23 and \$350,000 for FY 23-24, for the period of July 1, 2022, through June 30, 2024 (Agreement); and

**WHEREAS,** this First Amended Agreement adds \$150,000 in funding for FY 23-24 due to an unanticipated increase in services for a new total maximum contract amount not to exceed **\$715,000**, consisting of \$215,000 for FY 22-23 and \$500,000 for FY 23-24, for the period of July 1, 2022, through June 30, 2024.

**NOW, THEREFORE,** in consideration of the mutual covenants and conditions contained herein, the parties agree as follows:

## I. <u>Delete Section 1 (CONTRACTOR SERVICES) of Exhibit B Financial Provisions – MHS and replace it with the following:</u>

1. CONTRACTOR SERVICES. For services to be rendered under this Agreement, Contractor shall be paid at the rate specified in the Schedule of Rates (Exhibit B-1), with a maximum value not to exceed \$715,000 ("Contract Maximum") for FY 22-24, inclusive of \$215,000 for FY 22-23 and \$500,000 for FY 23-24. Notwithstanding any other provision of this Agreement, in no event shall County pay Contractor more than the Contract Maximum for Contractor's performance hereunder without a properly executed amendment.

## II. <u>Delete Exhibit B-1- MHS Schedule of Rates and Contract Maximum</u> in its entirety and replace it with the following:

<sup>\*</sup> In special situations, the daily rate may be adjusted by the Director and/or his designee to accommodate clients with acute needs, additional monitoring, or medical complexity. Rate change must be pre-authorized by Behavioral Wellness.

<sup>\*\*</sup> For clients with behavioral patches in the higher acuity rate class, the bed hold rate will be equal to the negotiated rate for the first two weeks of the bed hold and then revert to the basic daily care rate of \$140-\$160 thereafter. For clients with private or more secure rooms in the higher acuity rate class, the bed hold rate will be the same as the negotiated rate.

- III. Effectiveness. The terms and provisions set forth in this First Amended Agreement shall modify and supersede all inconsistent terms and provisions set forth in the original Agreement. The terms and provisions of the original Agreement, except as expressly modified and superseded by the First Amended Agreement, is ratified and confirmed and shall continue in full force and effect and shall continue to be legal, valid, binding, and enforceable obligations of the parties.
- **IV. Execution of Counterparts.** This First Amended Agreement may be executed in any number of counterparts, and each of such counterparts shall for all purposes be deemed to be an original, and all such counterparts, or as many of them as the parties shall preserve undestroyed, shall together constitute one and the same instrument.
