Title: Increase Appropriations in the Public Works Fund 1930

Budget Action: Increase Appropriations of \$3,764,100 in Public Works Resource Recovery and Waste Management Fund for Services and Supplies (\$130,000) and Capital Assets

(\$3,634,100) funded by release of Retained Earnings.

Justification: As part of the termination of the Operating Agreement with MSB Investors, and for the continuity of operations, the County assumed operation of the ADF and CMU until

such time that an agreement with a separate operator can be implemented.

Part of the operation of the ReSource Center includes the processing of organic waste into compost at the ADF and CMU facilities. This involves the moving and screening of the organic material in its various forms. Loaders are required to move organic material into the digesters, mixing with digestate, and shaping the digestate into rows for further curing through the Sustainable Generations GORE® covered aerated static pile system, and moving the cured material to the screens. The screening equipment is used to separate inorganic matter from the cured digestate. The loaders are also used to move and load the final compost product. The procurement of capital assets includes two power screens and four loaders totaling \$3,764,100.
