

SECOND AMENDMENT TO THE

1. **CONTRACT TERM:** The last sentence of Section 4 (Performance Period), Paragraph A of the Agreement, as amended by Amendment #1, is replaced with the following: "The Agreement shall end on **December 31, 2024**, unless extended pursuant to Section 35 of this Agreement, or unless earlier terminated."

Except as expressly amended by this Amendment, the Agreement remains in full force and effect.




