**Recommended Actions:**

That the Board of Supervisors:

- a) Approve budget revisions and transfers necessary to close the County's accounting records for County funds for the fiscal year ended June 30, 2024 (Fiscal Year 23-24) which require 4/5 approval vote from the Board of Supervisors.
- b) Determine that the above actions are not a project under the California Environmental Quality Act (CEQA) pursuant to Section 15378(c) of the CEQA Guidelines because they consist of the creation of government funding mechanisms which do not involve any commitment to any specific project which may result in a potentially significant physical impact on the environment.

**Summary Text:**

On June 4<sup>th</sup>, 2024, your Board directed the Auditor-Controller to compile and record the transfers and revisions of appropriations necessary to close the County's accounting records for all County Funds effective for the Fiscal Year ended June 30, 2024; pending approval by your Board at the July 9<sup>th</sup>, July 16<sup>th</sup>, August 20<sup>th</sup>, and August 27<sup>th</sup> meetings.

**Background:** The year-end closing process is accomplished during the period from June 30<sup>th</sup> to July 11<sup>th</sup>. During this process, there may be certain inter-fund transfers, contingency transfers, revisions, or adjustments necessary to efficiently and effectively accomplish the closing process. Those revisions received as of the docketing deadline are attached.
