

AMENDMENT NO. 2 TO AGREEMENT FOR PROFESSIONAL LEGAL SERVICES

This Amendment No. 2 hereby amends the Agreement for Professional Legal Services (Agreement) between the County of Santa Barbara, a political subdivision of the State of California (hereafter COUNTY) and Rimôn, P.C. (hereafter ATTORNEY).

For good and valuable consideration, the parties hereby amend the Agreement as follows:

Section 4 is replaced with the following:

4. **TERM.** ATTORNEY shall commence performance on September 15, 2020 and end performance upon completion, but no later than September 14, 2026 unless otherwise directed by COUNTY or unless earlier terminated.

Exhibit B, Section A is replaced with the following:

- A. For ATTORNEY services to be rendered under this Agreement, ATTORNEY shall be paid a total contract amount, including cost reimbursements, not to exceed \$115,000.

This Amendment No. 2 may be executed in any number of counterparts and each of such counterparts shall for all purposes be deemed to be an original; and all such counterparts, or as many of them as the parties shall preserve undestroyed, shall together constitute one and the same instrument.

All other terms remain in full force and effect.
