#### **Recommended Actions:**

On February 21, 2012, set hearing for March 13, 2012 to consider the recommendations of the County Planning Commission to approve Case Nos. 11ORD-00000-00017 and 11ORD-00000-00018 which would amend, respectively, the County Land Use and Development Code and the Article II Coastal Zoning Ordinance, to implement amendments establishing a permit process for the closure of mobilehome parks.

On March 13, 2012, your Board should consider the following actions:

## A. Case No. 11ORD-00000-00017 (Land Use and Development Code Amendment)

- 1. Make the findings for approval of the proposed amendments;
- 2. Determine that the adoption of this ordinance is categorically exempt from the California Environmental Quality Act pursuant to Section 15061(b)(3) of the Guidelines for Implementation of CEQA; and,
- 3. Approve Case No. 11ORD-00000-00017, an ordinance amending Section 35-1, the Santa Barbara County Land Use and Development Code, of Chapter 35, Zoning, of the County Code.

#### B. Case No. 11ORD-00000-00018 (Coastal Zoning Ordinance Amendment)

- 1. Make the findings for approval of the proposed amendments;
- 2. Determine that the adoption of this ordinance is categorically exempt from the California Environmental Quality Act pursuant to Section 15061(b)(3) of the Guidelines for Implementation of CEQA; and,
- 3. Approve Case No. 11ORD-00000-00018, an ordinance amending Article II, the Santa Barbara County Coastal Zoning Ordinance, of Chapter 35, Zoning, of the County Code.
