Budget Revision Requests

Title: Revise Social Services budget for Changes in Federal and State Funding and Updated Projections

Budget Action: Establish appropriations of \$7.7M to increase Restricted & Committed Fund Balance, increase appropriations of \$1.3M in Services & Supplies, \$0.9M in Other

Financing Uses, \$0.1M in Salaries and Benefits, \$0.05M in Fixed Assets all in the Social Services Department Funds funded by unanticipated revenue of :

Federal \$1.4M. State of \$4.8M. Other Financing Sources of \$0.9M. Misc Revenue of \$0.5M and a decrease in Other Charges (Cash Assistance Payment)

Justification: For FY 2012-13, to comply with the County policy of having an adopted budget prior to the start of the new fiscal year, the Department completed and

submitted its budget in the spring of 2012. The State budget was not adopted until June 30, 2012. Because of the timing of these different budget cycles, the Department must use prior year State allocations as estimates for building its FY 12-13 Recommended budget. Additionally, caseload projections were completed 6 months prior to the beginning of the FY 12-13 budget year. When the Department actually receives State funding allocations, usually in the Fall, the Department then develops a new operating plan which includes funding increases/decreases and policy changes adopted by the State. The revised budget also includes updated caseload projections. As a result of these changes, the Department is submitting to the Board of Supervisors a revised FY 12-13 budget. This budget revision reflects these changes. The BRR also reflects a combined net increase in Restricted and Committed Fund Balance mainly

attributable to one-time additional revenue due to Realignment caseload growth, Realignment base increase, and a decrease in Cash Assistance payments.
