12. EXPERIENCE:

I am interested in serving on the State Council on Developmental Disabilities, Area Board IX to help advance the reinvestment of developmental services in the State of California. This interest stems from my experience as an Assembly Budget Consultant. During the worst recession since the great depression (2009-2011), I was responsible for the Developmental Services State Budget. During this time, my proudest accomplishment was the implementation of Budget Stakeholder Workgroups that included service recipients in the policy-making process. These workgroups helped write legislation that mitigated the impact of cuts to people with disabilities and protected the IPP process, including notices of reductions in the appropriate language. Through this process we maximized federal funds, scored departmental savings and managed to circumvent desired reductions. This experience made me knowledgeable of system-wide policy and evaluation processes. In addition, my academic interest revolves around the reinvestment and subsequent policy-making options to protect health and human services in California.

13. ADDITIONAL INFORMATION:

During my tenure in the State Legislature, I advised legislative members in two Budget Subcommittees, totaling \$9.7 billion. I am knowledgeable of the budget reductions passed during the budget crisis and I would like to help the State Council on Developmental Disabilities restore these services. I would also like to share my knowledge of funding for alternative housing by helping Area Board IX access State funding to develop alternative housing to reintegrate people with disabilities into the community, mirrored after 962 Homes and family-group homes. Qualitative and quantitative data proved to be critical when making budgetary decisions. As a result, I would like to utilize my qualitative and quantitative skills to develop surveys and aggregate data in our area that will help us defend the need for quality services. As a current member of the Santa Barbara Women's Political Committee I am also very interested in making sure that families have access and representation when they seek services and support. My most recent experience as a doctoral student, informs my decision to serve on the State Council for Developmental Disabilities. My graduate work develops a statewide model to implement Budget Stakeholder Workgroups and provides critical evidence to the importance of including service recipients in Legislative decision-making.
