Subject: HOME Investment Partnership (HOME) Program
Deadline Compliance Status Report

Please be advised that our records indicate that the Santa Barbara County HOME Consortium is in danger of missing its Commitment deadline which occurs on July 31, 2013. Due to statutory/regulatory requirements delineated below, any funds that have not been committed within the 24-month period shall be subject to deobligation.

The HOME Program statute provides that HOME funds are available to participating jurisdictions (PJs) for commitment to affordable housing for a period of 24 months after the last day of the month in which the Department of Housing and Urban Development (HUD) notifies the participating jurisdictions (PJs) of HUD's execution of the HOME Investment Partnerships Grant Agreement. The provisions are implemented by regulation at 24 CFR 92.500(d).

Attached is a copy of the Deadline Compliance Status Report which identifies the City's cumulative commitment requirement amount through the deadline date. The report shows that Santa Barbara County has a current commitment requirement shortfall of \$2,098,376. This information is updated monthly on the HOME website. 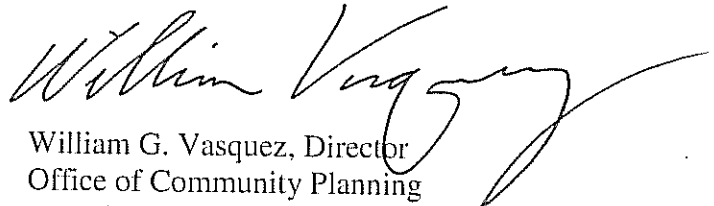

Prior to the requirement deadline, we are giving the County the opportunity to update IDIS with any commitments not previously recorded and/or to identify and correct errors in IDIS. Please note that any cancellation of activities may negatively impact the County's ability to meet its requirements. For more information on these requirements please refer to HUD Notice CPD 07-06, Commitment, CHDO Reservation, and Expenditure Deadline Requirements for the HOME Program.

Please make this an urgent priority and take all necessary remedial action or risk having the HOME funds de-obligated, which will mean that the above figures will be deducted from next year's HOME formula allocation for your County. The commitment data should be entered into HUD's Integrated Disbursement and Information System (IDIS) as soon as possible, especially before the July 31, 2013 deadline. Please be advised that statutory deadlines cannot be waived because they are based on Acts of Congress.
