Title: North County Transitional Housing Matching Funds

Budget Action: Transfer fund balance of \$3,672,828 from the Strategic Reserve Committed Fund Balance Account to SB 1022 Committed Fund Balance Account both in the General

Fund.

Justification:

This Budget Journal Entry will allow the County to submit an application to the Board of State and Community Corrections (BSCC) for funding from the SB-1022 Adult Local Criminal Justice Facilities Construction Financing Program. This program pays up to 90% of eligible expense for the design and construction, including expansion or renovation of adult local criminal justice facilities, up to \$40 million for a county our size. The application submits a proposal to expand the Northern Branch Jail by 228 beds. The expansion includes (2) 64 beds pods designated for treatment and programming and (2) 50 bed units to be used as for transitional housing.

The County is required by the RFP to provide a minimum of 10% match funds, in cash or eligible in-kind expenses, to be eligible for the grant. For SB-1022, the County's total match equals \$4,685,100, of which \$2,210,000 is Cash, \$2,249,000 in eligible in-kind match expenses and \$226,100 in Ineligible Costs. Of the in-kind match expenses, \$785,000 was already spent on the land, so the required match for the SB-1022 application is \$3,900,100.
