RESOLUTION TO DECLARE SANTA BARBARA)
COUNTY'S UTILIZATION OF THE 60/40 FORMULA)

FISCAL YEAR 2013-14 AND FOLLOWING YEARS) RESOLUTION NO. _____

WHEREAS, the California State Governor approved the FY 2013-14 Budget making statutory changes to implement the Patient Protection and Affordable Care Act of 2012 (commonly known as ACA) in California; and

WHEREAS, significant elements of the State's actions for ACA include the establishment of the new Medi-Cal benefit package for the expanded ACA population; and

WHEREAS, the significant fiscal implications resulting from these actions include modification of the 1991 Health Realignment funding structure, which redirects \$300 million in statewide funding in FY 2013-14, of which Santa Barbara County's share of this reduction of funds will be approximately \$2.3 million; and

WHEREAS, the State has provided two options for counties to determine the amount of 1991 Health Realignment funding that will be redirected to the State: either a *60/40 Formula* or a *Savings Share Formula*; and

WHEREAS, on September 17, 2013, the Santa Barbara County Board of Supervisors approved the choice of the 60/40 Formula *tentatively*; and

WHEREAS, that tentative decision was communicated to the State Department of Health Care Services (DHCS) by the deadline of November 1, 2013; and

WHEREAS, for Fiscal Year 2013-14 and following years, the State Department of Health Care Services (DHCS) requires a Resolution declaring Santa Barbara County's final choice of the two options by the deadline of January 22, 2014; and

WHEREAS, after due diligence and thorough analysis of the two options, Santa Barbara County's final decision is to utilize the 60/40 Formula;

NOW, THEREFORE, BE IT RESOLVED AND ORDERED that above is true and correct and that the County of Santa Barbara will use the 60/40 Formula for 1991 Public Health Realignment sharing with the State of California and directs the County Executive Officer, or her designee, to inform the California Department of Health Care Services of this decision.
