WHEREAS, Ronald L. Mose was born in Bay Shore, Long Island, New York and raised in Kings Park, Long Island, New York. He received his Associated Degree in Correctional Administration from the State University New York (SUNY) at Farmingdale and in 1978 received his BA in Public Justice from SUNY at Oswego; and

WHEREAS, Ron entered public service in 1979 as an Extra Help Group Counselor I, for the Orange County Probation Department and then the Santa Barbara County Probation Department as a Deputy Probation Officer II in May 1986; and has served as a Deputy Probation Officer III/Senior and Supervising Probation Officer in Santa Maria and Lompoc in the Adult and Juvenile divisions; and

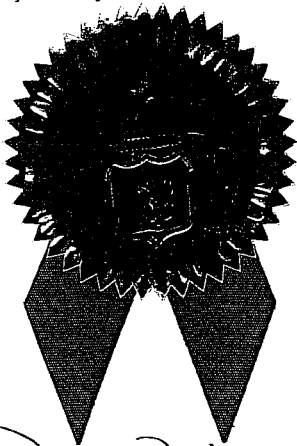
WHEREAS, Officer Mose was one of the first ten officers in the Department to become armed during his assignment to an adult high risk caseload; and became a state certified drug and alcohol counselor while assigned to the Lompoc Counseling and Education Center; and received the Santa Maria Elks Deputy Probation Officer of the year award in 2001; and

WHEREAS, Officer Mose was assigned to the Special Projects unit for over three years during which he researched and participated in the writing of nine grants for the Department which resulted in the awarding of almost \$1.4 million, including the Santa Maria Veteran's Treatment Court grant, the Domestic Violence BEST grants, the Office of Traffic Safety grants and the Drug Court Re-Entry grant; and

WHEREAS, he has also encouraged positive activities as a baseball umpire at the college and high school levels, for which he was selected to officiate at the 2007 High School CIF Finals. Ron is the proud son of Leo and Mae, husband of Cathy, father to Michael and step-father to Danielle and Johnny, brother to Kathryn and Jeanette and grandfather to Sienna, Savannah, Olivia and Vincent. Ron is now looking forward to spending time with his family and having free time to enjoy traveling and gardening.

NOW, THEREFORE, IT IS HEREBY ORDERED AND RESOLVED that the Board of Supervisors does hereby commended Supervising Probation Officer Ronald L. Mose upon his retirement for 27 years of service to the citizens of Santa Barbara County, and to the Probation Department.
