- b) Find that pursuant to the California Environmental Quality Act (CEQA) Guidelines section 15162, no substantial changes are proposed, there are no substantial changes in circumstances and no new information of substantial importance has come to light regarding environmental effects of the project or feasibility of mitigation measures and, therefore this action is within the scope of the project covered by the Environmental Impact Report/Environmental Impact Statement (EIR/EIS) for the Lower Mission Creek Flood Control Project as well as the Findings, and Statement of Overriding Considerations approved and adopted by the Board on May 10, 2011, and therefore, no subsequent environmental document is required. Summary Text:

The Lower Mission Creek Project, Reach 1A, widens the creek channel from State Street to Mason Street, in the City of Santa Barbara. Reach 1A - Phase 1, extending from State Street to just upstream of Harbor View Inn Pedestrian Bridge, was constructed in 2011. Reach 1A - Phase 2, which will complete the creek channel widening to Mason Street, is anticipated to be constructed beginning in 2014. Staff is negotiating a Cost Sharing Agreement with the City of Santa Barbara for the construction of Reach 1A-Phase 2 to be built concurrent with the City's Mason Street Bridge Replacement Project and will return to the Board for the Agreement's execution.

The new channel walls proposed as part of the Lower Mission Creek Project, Reach 1A – Phase 2, conflict with, and require the relocation and modification of, two water lines serving the Harbor View Inn as well as a portion of the hotel's parking lot. Construction of the Lower Mission Creek Project, Reach 1A – Water Relocation and Parking Lot Modification, is anticipated to begin construction in early 2014, in advance of the start of the Reach 1A – Phase 2 Project and in coordination with the Harbor View Inn to minimize impacts to the hotel's operations.

Background:

The Lower Mission Creek Flood Control Project is a Federal, U.S. Army Corps of Engineers, Project that has been under development since the 1960's. The City and the County, acting as local sponsors for the Federal Project, worked with the community in the 1990s to develop the current project that addresses the flood control concerns and environmental issues.

In 2001, the City certified the EIR/EIS and approved the Project for Lower Mission Creek as did the U.S Army Corps of Engineers subsequent to the City's approval. Since that time, federal funding for construction has not come forward and the City and the County have been working on finding opportunities to construct elements of the project as funding options arise.
