Attachment-6 of this Board Letter, dated January 21, 2014) and adopt the mitigation monitoring program contained in the conditions of approval; and,

4. Approve *de novo* the project, Case Numbers 06CDH-00000-00038, 06CDH-00000-00039, 09CDP-00000-00045, 07CUP-00000-00065, 10CUP-00000-00039, and 10CDP-00000-00094 subject to the conditions of approval included as Attachment-2 of the February 4, 2014 Board Letter.
