
Dear Supervisor Wolf:

We encourage the Board of Supervisors to appoint Dr. Ransohoff to the CenCal Health Board of Directors.

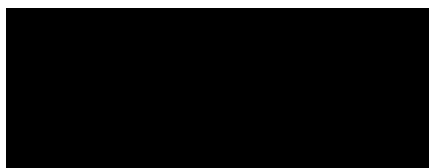
