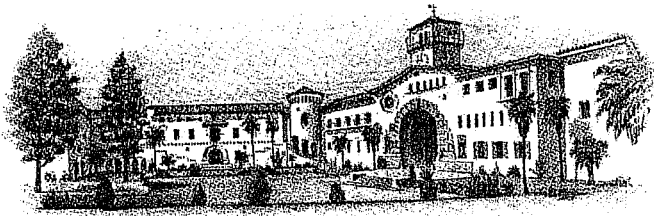

RESOLUTION OF COMMENDATION FOR PATRICIA MANFREDONIA CHAIR, WORKFORCE INVESTMENT BOARD OF SANTA BARBARA COUNTY

WHEREAS, Patricia Manfredonia has served as the Chair of the Workforce Investment Board of Santa Barbara County from July 2008 - December 2013; and

WHEREAS, under the leadership of Patricia Manfredonia, the Workforce Investment Board has administered over \$36 million of public funds to assist the county's job seekers to obtain the skills necessary to find employment at livable wages; and

WHEREAS, under the leadership of Patricia Manfredonia, the Workforce Investment Board has (for the first time) repeatedly met or exceeded its mandated, National Performance Measures; and

WHEREAS, under the leadership of Patricia Manfredonia, the Workforce Investment Board has forged a regional workforce partnership with the San Luis Obispo WIB and Ventura County WIB in order to bring more funding to the Central Coast; and

WHEREAS, under the leadership of Patricia Manfredonia, the Workforce Investment Board has created a Youth Advisory Council, composed of one-third youth, to advise the Board on youth policy and direction; and

NOW THEREFORE BE IT RESOLVED AND ORDERED that the Board of Supervisors honors and commends Patricia Manfredonia for her service as the chairwoman of the Workforce Investment Board of Santa Barbara County and for her outstanding contributions to assisting county residents to achieve Income Mobility, earn their way out of poverty, and enjoy an improved quality of life.
