WHEREAS, the California Arts Council and the California State Legislature have established a State Local Partnership Program (SLPP) designed to encourage local cultural planning and programming; and

WHEREAS, as part of the Santa Barbara County Arts Commission's application for a 2014/2015 SLPP grant, the California Arts Council requires that the Santa Barbara County Arts Commission obtain a resolution from the Board of Supervisors of the County of Santa Barbara that designates the Santa Barbara County Arts Commission as the County's partner in the State-Local Partnership Program and approves and authorizes the Santa Barbara County Arts Commission to submit the proposal and to execute the grant contract if awarded.

NOW, THEREFORE IT IS HEREBY RESOLVED BY THE BOARD OF SUPERVISORS OF SANTA BARBARA COUNTY as follows:

1. The Santa Barbara County Arts Commission, a division of the Community Services Department, is designated to serve as the County's partner in the State-Local Partnership Program (SLPP);
2. The Santa Barbara County Arts Commission is approved and authorized to submit an application for a 2014/2015 SLPP grant to the California Arts Council; and
3. The Santa Barbara Arts Commission is approved and authorized to execute the grant agreement if awarded by the California Arts Council.
