#### **Recommended Actions:**

That the Board of Supervisors:

- A. Consider the introduction (first reading) of the attached Ordinance amending Santa Barbara County Code, Chapter 9, pertaining to the removal of abandoned bicycles in the public right-of-way (15 minutes);
- B. On March 11, 2014 (Administrative Agenda):
  - i.) Consider the adoption (second reading) of an Ordinance, amending Santa Barbara County Code, Chapter 9 pertaining to bicycles in all Districts;
  - ii.) Read the title of the Ordinance and waive the reading of the Ordinance in full;
  - iii.) Find that the proposed action is for the operation and maintenance of existing public facilities, involving negligible, or no expansion of use beyond that which presently exists, that the proposed action is therefore exempt from the California Environmental Quality Act (CEQA) pursuant to 14 CCR 15301; and
  - iv.) Approve the filing of a Notice of Exemption on that basis.

### **Summary Text:**

Public Works allows permitted bicycle parking racks in the public right-of-way. Bike racks and usage are particularly intensive in Isla Vista. This bicycle parking in the right-of-way is intended for short-term durations (24 hours or less) while patronizing the local businesses or actively enjoying the area. Problems, such as theft and vandalism, arise when bicycles are parked long-term or abandoned in the right

of way. Abandoned and vandalized bikes lead to blight and take up spaces that should be available to active users.

Currently, the County Code does not provide for the impoundment of bicycles that are abandoned or illegally parked in the County right-of-way. Recommended changes would add sections to the County Code to allow for removal of abandoned bicycles. The new code would outline the process for identifying, tagging, removing, storing, and disposing abandoned bicycles.



#### **Background:**

Isla Vista has the highest bicycle use in the County with as many as 1,000 bicyclists per hour on Pardall Road. Most commercial property in downtown Isla Vista does not have adequate space to install bicycle parking. Due to high demand and public benefit of bicycle parking, Public Work has permitted bicycle parking racks in the public right-of-way at locations that are visible, lighted, and do not impede cars or pedestrians. Currently, Isla Vista is the only location where Public Works has permitted bicycle parking in the public right-of-way.

The bicycle parking racks are intended for short-term parking. Bicycles parked long-term are more likely to be vandalized or stolen, and long-term use decreases available parking for short-term users. Staff finds

that a large number of bicycles parked long-term in this area have actually been abandoned, and the County Code currently does not provide for removing and disposing them. The amendment to Chapter 9 of the County Code would give the County authority, and outline the process for identifying, notifying owners, storing, and disposing abandoned bicycles, all of which will be handled by the Sheriff's Department.
