Recommended Actions:

That the Board of Supervisors:

1) Approve the budget revision request of the Agricultural Commissioner/Weights & Measures Department to increase revenue (LI 4000) in the amount of \$26,453 from unanticipated unclaimed gas tax revenue and to increase expenditures in salaries and benefits (LI 6100) in the same amount.

Summary Text:

The Department will allocate \$26,453 to salaries and benefits (LI 6100) to fund an existing, unfunded Agricultural Biologist position for the remainder of FY 13-14 with no impact to the General Fund. Future funding for the position will come from a combination of revenue sources: unclaimed gas tax, pesticide mil tax, and state/federal revenue contracts.

Background:

The Department needs to fill the position to meet the increasing demand for services. Loss of staff due to one biologist leaving County employment and 2 others taking extended leaves have jeopardized the Department's ability to do so. In addition, one of the employees on leave will only be returning as a .6 FTE. Activities in jeopardy include conducting pesticide use monitoring inspections, inspecting plant shipments for invasive pests, and issuing Phytosanitary certificates that enable local farmers to ship their

product to other states and other countries. The loss of staff also jeopardizes the ability of the Department to meet its Maintenance of Effort (MOE) agreement with the California Department of Food and Agriculture as specified in the California Food and Agricultural Code Section 224.5(a)(3) that requires the County to "maintain county general fund support for agricultural commissioner services at least equal to the average amount expended for the five preceding fiscal years". Failure to meet the MOE levels puts the Department's major outside revenue source, the unclaimed gas tax, at risk.
