Funding for Agricultural Biologist I Position

Budget Action: Increase appropriations of \$26,453 in the Agricultural Commissioner General Fund for Salaries and Benefits funded by unanticipated revenue from State unclaimed gas

Justification:

The department needs to fill the position to meet the increasing demand for services. Loss of staff time due to one biologist leaving County employment and 2 others taking extended leaves have jeopardized the Department's ability to do so. In addition, one of the employees on leave will be returning as a .6 FTE. Activities in jeopardy include conducting pesticide use monitoring inspections, inspecting plant shipments for invasive pests, and issuing phytosanitary certificates that enable local farmers to ship their product to other states and other countries.

Funding for the position for the remainder of FY 13-14 will come from unanticipated state revenue in the form of unclaimed gas tax with no GFC impact. Ongoing funding in subsequent fiscal years will come from a combination of revenue sources (Unclaimed Gas Tax, Mil Tax, and state/federal revenue contracts) with no GFC impact.
