Recognize a transfer of federal asset seizure funds from LA Impact to the Santa Barbara Regional Narcotics Enforcement Team (SBRNET). Funds to be Justification:

distributed to City of Guadalupe to purchase a vehicle to be used by the task force member.

The Department of Justice Asset Forfeiture Program is a nationwide law enforcement initiative that removes the tools of crime from criminal organizations, deprives wrongdoers of the proceeds of their crimes, recovers property that may be used to compensate victims, and deters crime. The most important objective of the Program is law enforcement. Equitable sharing further enhances this law enforcement objective by fostering cooperation among federal, state, and local law enforcement agencies.

Department of Justice policy requires shared monies and property to be used for law enforcement purposes. Sharing will be withheld from any state or local law enforcement agency where state or local law, regulation, or policy requires federal equitable sharing funds to be transferred to non-law enforcement agencies or expended for non-law enforcement purposes.

LA Impact and SBRNET are both regional narcotics enforcement task forces that receive federal asset seizure funds. This transaction is a transfer of federal asset seizure funds from one task force to another.
