**Recommended Actions:**

1. Approve for signature by the Chair of the Board, contract between the County of Santa Barbara and the Santa Maria Fairpark for the Santa Barbara County Veteran's Stand Down on October 18, 2014.
2. Find that the proposed action consists of the normal operation of existing facilities for public gatherings for the purpose for which the facilities were designed, and is therefore exempt from CEQA pursuant to 14 CCR 15322; direct staff to file a Notice of Exemption with the Clerk of the Board on that basis.

**Summary Text:**

The Santa Barbara County Veteran Stand Down on October 18, 2014, will provide a wide variety of services to homeless veterans, veterans and veteran family members from across the county. Board approval is requested since the contract obligates the County to indemnify the 37<sup>th</sup> District Agricultural Association and the State of California from liability for damage or loss arising out of the use of Fairpark property by the County.

**Background:**

The Santa Barbara County Veteran Stand Down is planned for October 18, 2014. The planning committee includes a large number and diverse cross-section of individuals, governmental entities, nonprofits, active duty military, veterans and private organizations. The committee members volunteer on 25 different committees. The volunteers are pooling their resources and energy to extend a helping hand and offer hope and tangible assistance to homeless veterans.

The Committee has chosen to hold a one-day event at the Santa Maria Fairpark. The one-day event will serve men, women, and children and will provide shelter, medical, dental, clothing, showers, haircuts, food, counseling, legal assistance, employment training and other needed services.

The Fairpark was chosen because it will provide a safe enclosed area with onsite showers and rest rooms and large grassy areas for MASH tents and mobile dental, medical, and counseling units. The service providers, clothing distribution, and hair stylists will set up in the Park Plaza Building. The Fairpark also provides easy access for chow lines and picnic tables. This year the contract will be \$3,000 which will be paid with residual donations from last year's event.
