## Background

- In 1989, County had considered a Proposition 90 "Local Option"
- In September 2013, Board provided an option to re-evaluate Proposition 90
- Directed CEO staff to bring this back with more information and to notify all affected local agencies to elicit comments

## Proposition 60 and 90

#### **Proposition 60**

- Property tax relief is only allowed once
- Must be filed within 3 years of purchase
- Both properties must be located within County

#### **Proposition 90**

- Allows counties to accept Prop 60 base year value transfers from other counties if local option resolution is adopted by the Board
- Constitutional Amendment as of November 198
- SB County does not accept base values



## Proposition 90

Nine counties allow base year value transfers

## Impacts of Prop 90 in SBC

- Pro-rated impacts in surveyed counties –
   \$920,000 in SBC property tax reduction over 10 years
  - \$552,000 reduction to schools
  - \$184,000 reduction to cities/special districts
  - \$184,000 reduction to the County
- Sixty-two entities were invited to comment
- Nine entities responded
  - Eight opposed
  - One neutral



## Recent Proposition 90 Adoption

- Riverside began mid-September 2013
- Through end of February:
  - Eighteen approved
  - Fifty-two pending
  - Average \$192,000 base value reduction
- Prorated for SBC = 43 applications



### Recommended Actions

 Receive and file additional information on estimated tax revenue impacts that may result from implementing a Proposition 90 Local Option in Santa Barbara County.
