# Summary Text:

Copies of the easements are attached to the Purchase Contracts as Exhibit A. Acceptance and recordation of the easements will allow for the installation of sidewalks along the frontage of the north side of the 6500 block of Segovia Road. Installation of these improvements is consistent with the goals of the Isla Vista Master Plan and are funded by Measure A. The owners of the subject properties have agreed to execute the subject Easement Deeds in escrow. When accepted and recorded those Easement Deeds will convey the rights necessary for the installation and maintenance of the sidewalk improvements by the County.

## **Background:**

The subject easements and associated sidewalk installations are a result of the <u>Isla Vista Sidewalk</u> <u>Improvement Program</u>. This program is funded using Measure A funds administered by the County Public Works Department. The program is intended to improve the sidewalk system in Isla Vista by installing new sidewalks where none exist and improving curb ramps and driveway aprons to bring them into compliance with standards set by the Americans with Disabilities Act.

On January 22, 2002, your Board adopted Resolution 02-031 establishing compensation for the Isla Vista Sidewalk Project of twenty dollars (\$20.00) per square foot of easement area conveyed (Clerk of the Board File No. 02-00103).

The County currently owns ½ foot of right-of-way (ROW) on the north side of the 6500 block of Segovia Road. The subject easements would grant an additional 5 feet to the existing County ROW, this additional width will allow for the continued construction of sidewalk infill along Segovia Road.

#### Environmental Review:

Purchase of ROW for sidewalk network improvements was a component of the Isla Vista Master Plan, 03-EIR-08 which was approved by your Board on August 21, 2007. Environmental review of the

sidewalk ROW purchase under the California Environmental Quality Act (CEQA) has been performed pursuant to Public Resources Code Section 21090(b) in said Isla Vista Master Plan.

#### Government Code Consistency:

The Santa Barbara Planning Commission at its regular meeting of July 7, 2010 found that the acceptance of ROW for the Isla Vista Sidewalk Improvement Project is in conformity with the Comprehensive Plan, including the Goleta Community Plan and the Coastal Land Use Plan, pursuant to Government Code Section 65402(a).

Public Works Real Property will deliver the certified copies of the Contracts along with the original Easement Deeds (with Certificates of Acceptance) to First American Title to allow completion of escrow tasks. Real Property will inform the Clerk when the owners have signed the Easements, will deliver clean copies of the Certificates of Acceptance to the Clerk and will direct the Clerk to execute those Certificates in compliance with the Contracts. Those original Certificates will be delivered to escrow which will allow for recordation of the Easement Deeds, signaling the completion of escrow.
