Dear Clerk of the Board:

Please forward my letter to the entire Board of Supervisors in regards to the pending "appeal" of the demolition permit request for the Juarez/Hosmer Adobe, in Montecito.

The Juarez/Hosmer Adobe is in no worst condition than any of the other structures that I have restored in the past 25 years. The Juarez/Hosmer Adobe should not be demolished, but only is in need of being restored. I have seen much worst wood, with the overhead beams of the *Greene & Greene* 1902-1915 *Culbertson's Carriage House*, before and after photographs are attached above.

The City of Pasadena passed an ordinance which disallows any "new wood" to be used in the restoration of any *Greene & Greene* structure within City limits. A very wise move on their part, as all "new wood" is very inferior to "old growth" lumber. If I ever have to replace wood that is beyond restoration, I always use 100 years old wood from salvage yards that specialize in hunting down old growth woods.

I read in an email that there seems to be a wooden structure that has already been taken down, on the property. I hope the Board will address this alarming point.
