Recommended Actions:

That the Board of Supervisors:

- A. Approve and authorize the Chair of the Board of Supervisors to execute a CDBG funding contract in the amount of \$367,500.00, consisting of \$150,000.00 in CDBG funds already approved by the Board as part of the FY 2012-13 Annual Action Plan (Resolution No. 12-112) and \$217,500.00 in CDBG funds already approved by the Board as part of the FY 2013-14 Annual Action Plan (Resolution No. 13-171) (Attachment A); and
- B. Determine that approval and execution of the CDBG funding contract is exempt from the California Environmental Quality Act ("CEQA"), pursuant to Section 15301 of the State Guidelines for the Implementation of CEQA, which consists of the operation, repair, maintenance, permitting, leasing, licensing, or minor alterations of existing public or private structures, facilities, mechanical equipment, or topographical features, involving negligible or no expansion of existing use and approve the filing of a Notice of Exemption on that basis (Attachment B).

Summary:

Resolution No. 12-112, adopted May 8, 2012, approved CDBG funding for Capital Development Projects contained in the FY 2012-13 Annual Action Plan, including the City of Guadalupe American Legion Hall seismic retrofit, and Resolution No. 13-171, adopted June 18, 2013, approved funding for Capital Development Projects contained in the FY 2013-14 Annual Action Plan, including the City of

Guadalupe American Legion Hall seismic retrofit. This CDBG funding contract provides CDBG funds for the City of Guadalupe — American Legion Hall project that was included in the approved FY 2012-13 and FY 2013-14 Annual Action Plans after having undergone application review by County Housing and Community Development (HCD) staff, the County's Capital Loan Committee and the County Board of Supervisors.

Background:

The City of Guadalupe will carry out a seismic retrofit on the American Legion Hall building as required by the State of California. The American Legion Hall serves as the City's only community center facility serving the low-income residents of the City of Guadalupe.
