Title: ADMHS: Funding of Year End Deficit

Budget Action: Increase Appropriations of \$4,686,938 in ADMHS Mental Health Fund for Salaries & Benefits (\$132,158), Services & Supplies (\$3,609,570), and Other

Charges (\$945,210) funded by Intergovernmental Revenue (\$592,532), Charges for Services (\$1,958,386), Other Financing Sources (\$1,600,000) and Miscellaneous Revenue (\$536,020). Increase appropriations of \$1,600,000 in the General County Programs General Fund for Other Financing Uses funded

by a release of Committed Fund Balance.

Justification:

This budget revision recognizes \$4.7 million of expenses that are expected to exceed the budgeted amounts in the Mental Health Fund associated with inpatient contract beds (\$2.5 million), extra help staff (\$800K), temporary nurse and psychiatrists (\$500K), cost report settlements (\$600K) and other support services costs from other departments (\$300K). This increase in expenses is partially offset by an increase in State Realignment revenue (\$600K), an increase in Charges for Service revenues (\$2.0 million) and an increase in cost report settlement revenues (\$500K). These revenue increases total \$3.1 million. The remaining \$1.6 million in expenses will be covered by General Fund Contingency Committed fund balance from unanticipated revenue that was set aside in contingency for various issues such as the ADMHS inpatient contract bed costs. Only the amount actually needed to balance the Mental Health Fund at the end of the year will be transferred to ADMHS.
