## FOR THE FAMILY STRENGTHENING AND SUPPORT PROGRAM COMMUNITY DEVELOPMENT BLOCK GRANT (CDBG) PROGRAM

THIS FIRST AMENDMENT TO THE SUBRECIPIENT AGREEMENT ("First Amendment") is made by and between the

COUNTY OF SANTA BARBARA, a political subdivision of the State of California, hereinafter referred to as "COUNTY",

and

SANTA YNEZ VALLEY PEOPLE HELPING PEOPLE, a California nonprofit organization, hereinafter referred to as "SUBRECIPIENT";

with reference to the following:

WHEREAS, on July 2, 2013, COUNTY and SUBRECIPIENT entered into a Subrecipient Agreement for the Family Strengthening and Support Program funded by the CDBG Public Services Grant Program (hereinafter "Agreement"); and

WHEREAS, the Agreement sets forth SUBRECIPIENT's obligations regarding the provision of services as delineated in Section I, "Scope of Service"; and

WHEREAS, the Agreement sets forth the term of the Agreement as delineated in Exhibit B "Budget and Payment Procedures" which specifies that the Agreement is for \$24,656; and

WHEREAS, Section VI.E, "Changes or Amendments," of the Agreement provides that COUNTY and SUBRECIPIENT may amend the Agreement at any time provided that such amendments make specific reference to the Agreement, and are executed in writing, signed by a duly authorized representative of each party, and approved by COUNTY's governing body; and

WHEREAS, the Board of Supervisors considered and approved the proposed amendment on June 3, 2014; and

WHEREAS, the parties desire to modify and amend the term of the Agreement as set forth in Exhibit B "Budget and Payment Procedures", to specify that the Agreement shall be increased by \$12,125 from \$24,656 to \$36,781; and

WHEREAS, the parties desire to reduce the amount of Santa Ynez Valley People Helping People's FY 2014-15 CDBG grant award by \$12,125 from \$22,994 to \$10,869 as a result of increasing the FY 2013-14 CDBG grant award by \$12,125;

NOW, THEREFORE, the parties agree to amend the Agreement, as follows:
