FIRST AMENDMENT 2013-2014

TO AGREEMENT FOR SERVICES OF INDEPENDENT CONTRACTOR

This is an amendment (hereafter referred to as the "First Amended Contract") to the Agreement for Services of a Contractor on Payroll, <u>EID 9024</u>, by and between the **County of Santa Barbara** (County) and **Harold Ginsberg**, **MD** (Contractor), for the continued provision of **Psychiatric medication evaluation**, prescription and medication monitoring for co-occurring clients.

Whereas, Contractor represents that he is specially trained, skilled, experienced and competent to perform the special services required by County and County desires to retain the services of Contractor pursuant to the terms, covenants, and conditions referenced herein;

Whereas, this First Amended Contract incorporates the terms and conditions set forth in the contract approved by the County Board of Supervisors in June 2013, except as modified by this First Amended Contract.

Whereas, Contractor has agreed to provide, at the request of County, additional psychiatric services, funded by the State Bill 82 Crisis Triage Personnel Grant, in the Lompoc region. This amendment adds funds in the amount of \$11110 to the prior Agreement maximum of \$45760 so as to compensate Contractor for the additional services to be rendered under this Agreement through June 30, 2014.

NOW, THEREFORE, in consideration of the mutual covenants and conditions contained herein, County and Contractor agree as follows:

I. Delete Exhibit B, Contractor on Payroll Compensation, and replace with the following:

EXHIBIT B

CONTRACTOR ON PAYROLL

Compensation

COUNTY shall pay **CONTRACTOR** for professional services pursuant to this Agreement upon biweekly submission by **CONTRACTOR** of a timesheet, and such payment shall be subject to deductions and withholding of state and federal taxes. In no event shall the compensation payable exceed the total sum of \$56870 without written amendment. This not to exceed amount includes the following:

• \$56870 for 517 hours of work by **CONTRACTOR** at a rate of \$110.00 per hour.
