### Summary Text:

The Board's action to approve the donation will allow the Public Health Department to make conference room improvements, purchase outdoor tables and seating, and enhance landscaping at the Calle Real campus.

**Background:** The Service League of Santa Barbara General Hospital is a non-profit agency comprised of dedicated volunteers who run a gift shop on the Public Health Department Calle Real campus. As their name suggests, the group formed in 1969 when the County General Hospital was in existence. Currently there are 8 volunteers providing many hours of service; one long-time volunteer has logged 15,000 hours. The gift shop sells small gift items and packaged snack food. Over the years, the Service League has provided many donations that have benefitted the Department and its clients. Examples of

their contributions include portable baby scales, ophthalmology equipment, conference room furnishings, and dental program supplies.

The donation will be used for improving the conference rooms in the San Antonio Building which are used by many County departments as well as local non-profits. The funds will also purchase much needed outdoor tables and seating for use by our patients and staff. Any remaining funds will provide one-time landscaping improvements.
