Recommended Actions:

That the Board of Supervisors:

- A. Authorize the Chair to execute the attached Coastal Resource Enhancement Fund (CREF) contract with Channel Islands Restoration, for the period of June 17, 2014 to March 1, 2016, in the amount of \$30,901, for the Santa Barbara Zoo Wetland Margin Enhancement Project, located in Santa Barbara, in the First Supervisorial District (Attachment A).
- B. Authorize the Chair to execute the attached CREF contract with the Lompoc Unified School District, for the period of June 17, 2014 to December 15, 2014, in the amount of \$75,000, to install new exhibits at the Cabrillo High School Aquarium, located in Vandenberg Village near Lompoc, in the Third Supervisorial District (Attachment B).
- C. Authorize the Chair to execute the attached CREF contract with the Guadalupe-Nipomo Dunes Center, for the period of June 17, 2014 to March 1, 2016, in the amount of \$80,000, towards the

Sphinx Excavation, Restoration, and Exhibition project, located in the City of Guadalupe, in the Third Supervisorial District (Attachment C).

D. Determine that the allocation of the CREF grant for the Cabrillo High School Aquarium exhibits is exempt from CEQA pursuant to Section 15301(a) of the State Guidelines for the implementation of the California Environmental Quality Act (Attachment D).

Summary Text:

<u>Santa Barbara Zoo Wetland Margin Enhancement Project</u>. The Channel Islands Restoration would use the \$30,901 Coastal Resource Enhancement Fund (CREF) grant to restore 1.4 acres in between the Santa Barbara Zoo and the Andree Clark Bird Refuge. The total restoration costs are approximately \$120,000, and the grantee secured an additional \$88,900. The City of Santa Barbara exempted the project from further environmental review requirements of the California Environmental Quality Act (CEQA), as defined in Section 15333 – Small Habitat Restoration Projects – in the State Guidelines for the implementation of CEQA (Attachment E).

<u>Cabrillo High School Aquarium Exhibits</u>. The Lompoc Unified School District would use the \$75,000 CREF grant to expand the Aquarium space by 1,776 square feet and install two new exhibits. The total project costs are approximately \$85,000, and the grantee secured an additional \$10,000. The project would be exempt from further environmental review requirements of the California Environmental Quality Act (CEQA), as defined in Section 15301(a) – Existing Facilities – in the State Guidelines for the implementation of CEQA (Attachment D).

<u>Sphinx Excavation, Restoration, and Exhibition Project</u>. The Guadalupe-Nipomo Dunes Center would use the \$80,000 CREF grant to excavate a plastered sphinx body, which is partially buried at Guadalupe Dunes and was from *The Ten Commandments* 1923 movie set. The grantee would restore the sphinx and display the sphinx in an exhibit at the Guadalupe-Nipomo Dunes Center. The total project costs are \$118,244 and the grantee has secured an additional \$38,244 from various sources. The County of Santa Barbara permitted the project in 2011 and exempted the project from further environmental review requirements of the California Environmental Quality Act (CEQA), as defined in Section 15331 – Historical Resource Restoration/Rehabilitation – in the State Guidelines for the implementation of CEQA (Attachment F).

Background:

At the March 4, 2014 Board of Supervisors hearing, the Board of Supervisors awarded 12 Coastal Resource Enhancement Fund (CREF) grants from the 2014 CREF cycle, including the three subject grants:

- \$30,901 to the Channel Islands Restoration towards the final phase of its Santa Barbara Zoo Wetland Margin Enhancement Project.
- \$75,000 to the Lompoc Unified School District towards new exhibits at its Cabrillo High School Aquarium.
- \$80,000 to the Guadalupe-Nipomo Dunes Center towards its Sphinx Excavation, Restoration, and Exhibition project.

The three contracts (Attachments A, B, and C) execute the three grants described above.

Mitigation of impacts to coastal resources from offshore oil and gas development is required as a condition of permits on three projects. Mitigation is provided through the Coastal Resource Enhancement Fund.

No fiscal and facilities impacts. The Coastal Resource Enhancement Fund is funded by annual mitigation fees paid by developers of offshore oil and gas reserves. Fees to fund a grant were received in FY 13-14 and are included in the County's FY 13/14 Budget on page D-168 "Source of Funds Summary – Use of Prior Fund Balances." The \$30,901, \$75,000, and \$80,000 are expended from Fund #0063, Dept. #053, Program #5090, Account #7863, Project #1401, Project #1410, and Project #1411, respectively. Administration of CREF is budgeted at \$23,875 for FY 13/14.
