Recommended Actions:

That the Board of Supervisors:

- A. Approve and authorize the Chair to execute the attached Agreement for Services of Independent Contractor with Sentinel Offender Services, LLC., to provide electronic monitoring (EM) services for the Santa Maria Juvenile Hall (SMJH) for Fiscal Year (FY) 2014-15, FY 2015-16, and FY 2016-17, for a total contract amount not to exceed \$420,000 (Attachment A); and
- B. Determine that the approval of the Agreement is exempt from the California Environmental Quality Act (CEQA) pursuant to CEQA Guidelines Section 15061(b)(3), finding that this activity is covered by the general rule that CEQA applies only to projects which have the potential for causing a significant effect on the environment, and where it can be seen with certainty that there is no possibility that this activity may have a significant effect on the environment, the activity is not subject to CEQA, and direct staff to file a Notice of Exemption (Attachment B)..

Summary Text:

Sentinel Offender Services, LLC., has provided EM services for the SMJH under the current bid since FY 2011-12. (At the time, the company operated as G4S Justice Services, LLC., until acquired by Sentinel Offender Services. An amendment to the then-existing contract was executed in October of 2012 reflecting the change in company name.) Approving the attached Agreement

would continue services through FY 2016-17 with no change in cost from previous years and with the same terms.

Background:

The SMJH operates a home supervision program that includes the use of EM surveillance of certain juvenile offenders. The use of EM provides the Juvenile Court with an alternative to detention and allows youth released from custody on EM to remain in their homes under certain conditions and enables them to remain in school. Juvenile Institutions Officers assigned to the home supervision program regularly monitor the activities of those released on EM from program sites in Santa Maria and Santa Barbara for all areas. At any given time there are approximately 35-40 youth on EM. The Probation Department uses services and technology provided by Sentinel Offender Services, LLC., to perform EM functions. These include the kits, devices, and transmitters necessary to provide electronic information to officers.

Performance Measure:

Sentinel Offender Services will make immediate notifications to the Probation Department of any instances of offender non-compliance discovered by them through their remote monitoring system 24 hours per day.

Sentinel Offender Services will provide and replace necessary monitoring units and equipment upon request, accounting for administrative processing and delivery times.
