Summary Text:

The County Surveyor's Office is in receipt of a letter from Carpinteria Water, the entity that will provide water and Carpinteria Sanitary District, the entity that will provide the sewer service for Tract No. 14,729, which letters state that all arrangements have been made for water and sewer services for said Tract.

At its regularly scheduled meeting on May 28, 2008 the Santa Barbara County Planning Commission approved the proposed subdivision and adopted Negative Declaration 08NGD-00000-00008 for same.
