Title: Release fund balance for Jail Kitchen Project

Budget Action: Transfer appropriations of \$600,000 between Sheriff and General Services in the Capital Projects fund for Jail Kitchen project. Transfer appropriations of

\$300,000 in Sheriff General fund Restricted fund balance to General Services Capital Projects Fund for jail kitchen project.

Justification: The Main Jail Kitchen Renovation/Sewer Replacement Project will provide replacement of a failed sewer line in the main jail kitchen and replacement of

kitchen equipment which has exceeded its life expectancy and serviceability. On March 4, 2014, the Board approved plans and specifications for the Main Jail Kitchen Renovation/Sewer Replacement Project and authorized the Director of General Services to advertise for construction bids. The total project cost is funded by three (3) sources: 1. \$1,175,000 in Certificates of Participation (COP's) originally issued for the canceled Sheriff's Tech Services Building, and redirected towards this project by the Board on May 10, 2011 as a component of the "Project Substitutions for COP's Issued in 2005 and 2010".

2. \$600,000 from Aramark for the kitchen equipment and associated improvements as part of their contract with the County, the subject of this BRR.

3. \$300,000 funded by the Sheriff's Prop 172 funds, the subject of this BRR.
