Acceptance of Deed of Gift for "The Landing of Cabrillo" work of art

Budget Action: Establish appropriation of \$200,000 in the General Services Capital Outlay Fund for Capital Assets funded by a gift from the Santa Barbara County Docent Counsel

Justification:

The Docent Council (a non-profit 501(c)(3) corporation), working with the General Services Department, has agreed to formally donate a 9'-6" by 12'-3" painting entitled "The Landing of Cabrillo" by Dan Sayre Groesbeck (Painting), commissioned in 1924 and recently valued at \$200,000 (two hundred thousand dollars) to the County. The Painting hung in the Mural Room Lobby of the Santa Barbara Courthouse from 1994 through 2013. The Mural Room paintings were also painted by Mr. Groesbeck. In accordance with the Settlement Agreement, the Docent Council is formally offering to gift the Painting to the County of Santa Barbara to be made a permanent part of the Santa Barbara Courthouse Collection for public display. The gift needs to be accepted by the Board in compliance with County Policy D4.1 and Board Resolution 99-485, Acceptance of Gifts by County. Acceptance of the gift would resolve potential litigation by Mr. Cappello, against the County and other parties.
