#### **Recommended Action(s):**

On August 13, 2014, the number of candidates for the Special District Board of Directors/Trustees did not exceed the number of offices to be filled and a petition requesting that an election be held in the district was not presented to this office.

Pursuant to California Elections Code § 10515, the Board of Supervisors shall set a hearing to:

- a) Appoint in lieu of election those candidates who have filed the required nomination documents and have qualified. All candidates listed on "Attachment A" have filed nomination documents to run for office and meet the qualifications necessary to be appointed in lieu of election.
- b) Consider candidates that must qualify by November 4, 2014 for appointment to fill vacancies. The person(s) appointed shall take office and serve exactly as if elected. "Attachment B" lists eight (9) districts that have one or more vacancies where no candidates filed. In order to facilitate the appointment process it is recommended that the Board of Supervisors contact those district offices for recommendations for appointment.

The appointed candidates will take office on December 5, 2014; therefore, these appointments must be finalized prior to that date.
