Cancellation Fee for 10AGP-00000-00002

On September 9, 2014, the Board of Supervisors adopted Resolution 14-210 and executed the Certificate of Tentative Cancellation of Land Conservation Contract 76-AP-072 (10AGP-00000-00002) as Item D-5.

The subject Certificate of Tentative Cancellation requires the landowner to pay \$125,000 in cancellation fees prior to issuance of the Final Certificate of Cancellation, which will be considered by the Board of Supervisors on October 7, 2014.

Laurel Perez with Suzanne Elledge Planning & Permitting Services, Inc., agent for Cuyama Solar, Inc., submits the \$125,000 cancellation fee today to the Clerk of the Board.

Special Instructions included in the D-5 Board Agenda Letter for the September 9, 2014 hearing state that the Clerk of the Board shall:

- Transfer the landowner's Williamson Act cancellation fee to the County Treasurer; and
- Notify the Board of Supervisors that the cancellation fee has been paid.

When the Clerk of the Board is transferring the cancellation fee to the County Treasurer, please notify the Treasurer that if the Board of Supervisors executes the Final Certificate of Cancellation on October 7, 2014, the County Treasurer shall transmit the Williamson Act Cancellation fee (\$125,000) to the State Controller within 30 days of execution of the Final Certificate of Cancellation (Government Code Section 51283(e)).
