

Groundwater Basins

- **Groundwater Level Declines During Drought**
 - Lack of recharge from surface water
 - Increased extraction
 - Continuation of existing trends
- Lowest recorded measurements on record
 - Buellton Uplands, Lompoc Uplands, Santa Maria, and Cuyama Groundwater Basins
 - Localized Effects
- New Groundwater Legislation
 - Recently enacted Groundwater Bills: SB 1168, SB 1319, AB 1739
 - Require management of all County groundwater basins designated high or medium priority by DWR
 - Supplemental Regulation and Guidelines Under Development



Cachuma Lake

- Current Storage ~ 58,253 AF (30%)
- 2015 Allocation ~ 45%
- 7,700 AF (estimated) of carry over water available
- Decline of lake slowed by
 - reduced deliveries
 - maximum CCWA inflow




Deliveries From Lake Cachuma To The South Coast January-September 2013/14



EHS & Well Permits

- In FY2010/11 FY2012/13 = **57** applications
- In FY2013/14 alone = 165 applications
- FY2014/15 thus far, 28 have been submitted
- Majority are for irrigation wells in North County
- Montecito/Carpinteria: FY2013/14 = 80 applications
 - Previous average for this area: 9 applications per year.
 - Despite mandatory water restrictions, drilling wells will negate some water conservation gains in the area.
- Increased demand: long wait times (1 year+)
- Drilling rigs operating 7-days per week to meet demand, causing noise complaints.
