Recommended Actions:

- A. Approve and authorize the Chair to execute the Statement of Final Quantities for work performed and materials supplied for the Mud Lake Basin Siphon Improvement Project, Phase II by the contractor Raminha Construction, Inc. (a tri-county vendor) in the amount of \$359,630.46; and
- B. Find that the proposed Mud Lake Basin Siphon Improvement Project, Phase II, consists of minor trenching and backfilling where the surface is restored in order to replace the siphon pipe at an existing facility and that the proposed project is therefore exempt from the California Environmental Quality Act (CEQA) pursuant to CEQA Guidelines Section 14 CCR § 15304 (f) minor alterations to land, and 14 CCR § 15301 (d) existing facilities and that a CEQA Exemption for this project was approved by the Board of Directors and filed by the Clerk of the Board on July 1, 2014, therefore no new exemption is required for the approval of the recommended actions. Summary Text:

On September 16, 2014, the Board entered into an agreement with Raminha Construction, Inc., to construct the Mud Lake Basin Siphon Improvement Project, Phase II, in the amount of \$379,395.00, with a contingency approved in the amount of \$31,469.75. This project was completed at a cost of \$359,630.46.

This final phase of the project replaced the existing deteriorated siphon line that outlets from the Mud Lake Basin with a new gravity line installed by the Horizontal Directional Drilling method, a trenchless technology.

The Flood Control District has accepted the work of the contractor Raminha Construction, Inc., completed ontime and per plans and specifications. On October 27, 2014, the Public Works Director signed and executed a Notice of Completion (NOC) for the project and that the NOC was sent to the Clerk Recorder's office to be recorded.

Background:

The Mud Lake Basin is a storm water retention basin located within the Orcutt area of Santa Barbara County, east of Bradley Road and north of Clark Avenue and was constructed as part of the Village Hills Unit II Development (Tract 12,476) in 1981. The basin receives local drainage from the neighborhood and included a manually operated siphon pipe discharge system in the Valley Drive public right-of-way, draining to the north.

The basin could only be drained previously through the existing siphon line, which was discovered to be significantly deteriorated and has always been cumbersome to operate by Flood Control maintenance staff. When the basin becomes full and is not drained any excess inflow will spill onto local streets in an uncontrolled manner. The installation of this new gravity drain will allow for more efficient operation of the retention basin and significantly reduce the risk of the basin filling up and spilling.
