## Financial/Debt Overview

- Borrowed Money 6 year period
  - \$2.5 million total
- Building Debt
  - \$1 million (\$1million forgiven in September)
  - County Loan \$500,000
- Revenue Sources
  - 34% Foundation
  - 24% Contributions
  - 42% Government



## Recommendations

- 1. Receive and file a report regarding the Casa Esperanza Operational Assessment;
- 2. Approve and authorize the Chair to execute a Shelter Operations General Fund Grant Agreement in the amount of \$120,000 with Casa Esperanza Homeless Center through June 30, 2015;
- Approve and authorize the Chair to execute an Agreement for Services of Independent Contractor with Casa Esperanza Homeless Center to provide short term beds for Department of Social Services clients who are receiving Adult Protective Services (APS) while arrangements are made for transitional and/or permanent housing in an amount not to exceed \$19,305;

## Recommendations (cont'd.)

4. Approve and ratify the following Purchase Orders with Casa Esperanza Homeless Center:

 Find that the proposed actions do not constitute a "Project" within the meaning of California Environmental Quality Act, pursuant to 14 CCR 15378(b)(2), as they consist of general policy and procedure making. Operational Assessment Recommendations

- Release \$60,000 upon execution of the contract.
- Allocate remaining \$60,000 funds on a monthly basis (\$10,000 per month).

 Should additional funds be requested for FY 2015/16, Casa Esperanza would need to request via the budget development process.
