#### RESOLUTION NO.

**WHEREAS,** the Board of Supervisors on April 21, 2009 adopted Resolution No. 09-114, on July 1, 2014 adopted Resolution No. 14-161 and on July 21, 1975 adopted Resolution No. 75-567, which established various parking restrictions in the Isla Vista area; conditions have changed since these Resolutions were adopted and it has become necessary to revise the parking restrictions and

**NOW THEREFORE, IT IS HEREBY RESOLVED AND ORDERED,** that Resolution 09-114 which established Time Limited Parking on Embarcadero Del Mar, portions of Resolution 14-161 which established Time Limited Parking on Trigo Road and portions of Resolution 75-567 which established Time Limited Parking on Pardall Road are rescinded at hereinafter locations:

Time Limited Parking Zone (1 Hour Parking, 9:00 am to 6:00 pm, except holidays & Sundays)

• On the west side of Embarcadero Del Mar from a point 45 feet south of the centerline of Pardall Road to a point 218 feet south of the centerline of Pardall Road.

Time Limited Parking Zone (1 Hour Parking, 9:00 am to 5:00 pm, Monday through Friday, except holidays)

• On the north side of Trigo Road from a point 256 feet west of the centerline of Embarcadero Del Mar to a point 376 feet west of the centerline of Embarcadero Del Mar (Resolution 14-161).

Time Limited Parking Zone (15 Minute Parking, 9:00 am to 6:00 pm, excluding Sundays and holidays)

• On the north side of Trigo Road from a point 376 feet west of the centerline of Embarcadero Del Mar to a point 419 feet west of the centerline of Embarcadero Del Mar (Resolution 13-181).

Time Limited Parking Zone (1 Hour Parking)

• On the south side of Pardall Road between a point 200 feet west of the centerline of Embarcadero Del Mar and the centerline of Embarcadero Del Norte, except those portions having existing parking restrictions established by this Board pursuant to Resolutions 09-115, 10-186, 71-298, 73-46, 14-32 and 09-117.

**IT IS FURTHER RESOLVED** that the Santa Barbara County Director of Public Works or designee is hereby authorized and directed to remove appropriate markings and/or signs at said locations as time and resources permit.
