#13 Additional Information

As a nonprofit environmental leader, I have been working for several years to build additional leadership within the nonprofit sector in Santa Barbara County, with a particular emphasis on encouraging diversity and mentoring young women. Some of my efforts in this area include:

- I serve as a Board member of Leading From Within, a group formed by Ken Saxon.
- I serve as chair of an alumni group of 60+ nonprofit executives who have completed the Courage to Lead program – about 70% of whom are women.
- I am an alum of the Katherine Harvey Fellows program, which works to identify and nurture future nonprofit board members. I'm still actively involved with this group and sat on the selection committee for the most recent class.

In addition, I am actively involved in the community in other ways:

- I serve as the director of the Santa Barbara Earth Day Festival – an event that attracts approximately 40,000 people/year in April.
- I facilitate a partnership that includes representatives from the County of Santa Barbara, the cities of Carpinteria, Goleta and Santa Barbara, and the two utilities (Southern California Edison and Southern California Gas) to encourage energy efficiency – the South County Energy Efficiency Partnership.
- I serve on the steering committee of the countywide Green Business program, and have been leading a revisioning process for this program.
- I established and serve on the Executive Team for a new countywide effort to create a healthy and sustainable food system. This group is just getting started (no website yet), but please see the attached flyer that describes this effort. It is being co-chaired by Salud and Steve Lavagnino.

On a personal level, I am committed to mentoring young women, particularly through CEC's internship program, and through the programs and projects listed above. I believe strongly in working through collaboration and partnership, and feel that my networks could be put to good use in serving the Commission for Women. I'm also interested in learning from other Commissioners about issues and concerns that they are passionate about, and expanding my knowledge of the County.
