

**RESOLUTION OF THE BOARD OF SUPERVISORS OF THE

WHEREAS, Union Valley Parkway is a public road in Santa Barbara County, State of California, in the Orcutt area of said County; and

WHEREAS, Union Valley Parkway is currently open to the public from Highway 101 to Highway 135 with a daily traffic volume of over 12000 vehicles; and

WHEREAS, local agencies are responsible for initiating requests to change the functional classification of street and roads under their jurisdiction; and

WHEREAS, the County of Santa Barbara receives State and Federal road improvement and maintenance funding based on the street and road designation; and

WHEREAS, Union Valley Parkway is currently recorded by the State of California on the California Road System, Functional Classification System as a Minor Arterial from Boardwalk Lane to Hummel Drive and is unclassified from Highway 101 to Boardwalk Lane and from Hummel Drive to Highway 135; and

WHEREAS, Union Valley Parkway from Highway 101 to Highway 135 was designated as a future class P2 Major Arterial in the Orcutt Community Plan adopted by the Santa Barbara County Board of Supervisor on July 22, 1997 by Resolution No. 97-315; and

WHEREAS, reclassification of the portion of the Union Valley Parkway within the County's jurisdiction to a Principal Arterial is in the best interest of the neighboring communities and the traveling public; and

NOW THEREFORE, IT IS HEREBY RESOLVED AND ORDERED that the Board of Supervisors of the County of Santa Barbara does hereby approve the submittal of a Functional Classification Change to the State of California, Department of Transportation for Union Valley Parkway to be designated a Principal Arterial.
