That the Board of Supervisors:

a) Appoint Guadalupe Rabago, Chief Probation Officer to serve as the County Member Commissioner on the First 5 Children and Families Commission.

#### **Summary Text:**

The Commission shall consists of nine (9) regular members and four (4) alternate members all appointed by the Board of Supervisors. The members of the First 5 Children & Families Commission are required to devote a substantial amount of time attending monthly Commission meetings, evaluation of future funding proposals, monitors outcomes, and existing grants, and ongoing Strategic Plan.

Regular and alternate Commission members are expected to attend all meetings of the Commission. Commissioners shall notify the staff, in advance if they are unable to attend a meeting of the Commission.

### **Background:**

First 5 Children and Families Commission of Santa Barbara County (First 5) was established in 1999 after California voters passed Proposition 10, a state constitutional amendment. Proposition 10 imposed a sales tax on tobacco products and directed that those revenues be used to support early childhood development focusing on children prenatal through age five.
