Title: Establish and Transfer Appropriations For Animal Services Ballistic Vest Grant Program

Budget Action: Establish appropriations of \$5,600 in the Public Health Department's Animal Services General Fund Services and Supplies funded by unanticipated revenue from the

National Animal Control Association (NACA) Officer Roy Marcum Ballistic Vest Grant Program (\$4,000) and transfer from Salaries and Benefits (\$1,600) for the purchase

of the ballistic vests.

Justification: Approving the acceptance of the \$4,000 grant from the National Animal Control Association (NACA) Officer Roy Marcum Ballistic Vest Grant Program does not affect

mandates or service levels. The grant has been received and deposited in the Public Health Department's Animal Services General Fund. The \$4,000 grant will be used

to assist with the purchase of 8 life-saving ballistic vests and 6 outer vest crossover carriers for a total estimated cost of \$5,600.

Approving the budget revision will establish appropriations of \$5,600 in the Public Health Department's Animal Services General Fund Services and Supplies funded by the \$4,000 NACA grant and a transfer of \$1,600 from Salaries and Benefits, due to salary savings from vacancies.
