RESOLUTION OF THE BOARD OF EDUCATION OF THE CARPINTERIA UNIFIED SCHOOL DISTRICT ENTERING ELECTION RESULTS INTO THE MINUTES AND CERTIFYING TO THE BOARD OF SUPERVISORS OF SANTA BARBARA COUNTY ALL PROCEEDINGS IN THE NOVEMBER 4, 2014 GENERAL OBLIGATION BOND ELECTION

WHEREAS, the Board of the Carpinteria Unified School District (the "District") previously adopted a resolution requesting Santa Barbara County (the "County") to call an election for general obligation bonds (the "Bond Election") to be held on November 4, 2014; and

WHEREAS, the Board of the District has received from the Registrar of Voters/County Clerk-Recorder the Canvass Certificate and Official Statement of Results (the "Canvass") of the Bond Election; and

WHEREAS, it appears from the Canvass, a copy of which is attached hereto as Exhibit "A," that more than fifty-five percent of the votes cast on Measure U were in favor of issuing the aforementioned bonds.

NOW, THEREFORE, THE BOARD OF THE CARPINTERIA UNIFIED SCHOOL DISTRICT DOES HEREBY FIND, DETERMINE AND CERTIFY AS FOLLOWS:

- Section 1. That entry be made upon the minutes of the meeting that Measure U has been approved by more than fifty-five percent of the votes cast at the Bond Election.
- Section 2. That all proceedings of the District in connection with the Bond Election have been accomplished according to law.
- Section 3. That the Secretary of the Board is hereby requested to deliver a copy of this Resolution with the Canvass to the County Superintendent of Schools and the Clerk of the Board of Supervisors of the County.
